ADD 10% FILING FEE TO THE STATE BOARD OF EQUALIZATION IF FILED IN DECEMBER	
T/M PROJECTS SHALL BE COMPUTED AT FULLY BURDENED RATE AS CALCULATED FOR EQUIVALENT COUNTY POSITION WITH A MINIMUM <b>\$5,000 DEPOSIT</b>
