## LAFCO MINUTES

## June 28, 2007

The Local Agency Formation Commission (LAFCO) convened a regular meeting on June 28, 2007, at 8:30 a.m. in the Imperial County Board of Supervisors Chambers, 940 Main Street, El Centro, California. Commissioners present were Snively, Leimgruber, O'Malley, Ludwig, Stapleton, and Maruca. Commissioner Benson and Carrillo were absent.

Staff present was the Executive Officer Heuberger, Legal Counsel Yeager and Secretary Soto.

2. A motion made by Commissioner Maruca, by unanimous roll call vote approved the minutes of May 24, 2007.

The Executive Officer requested from the Commission an Emergency item regarding discussion\action response to the Grand Jury report that is due. The Commission adopted the motion by Commissioner Leimgruber to have the emergency item added as requested by the Executive Officer. The Commission adopted the motion by Commissioner Leimgruber to approve the response letter as requested by the Executive Officer. The motion carried on the affirmative roll call vote of all Commissioners present.

3. Public hearing on a proposed annexation to the City of El Centro, being EC 01-05 (Willow Bend project) as submitted by Development Design & Engineering:

The Commission adopted the motion by Commissioner Maruca to continue the project for a period not to exceed 70 days. The Motion carried on the affirmative roll call vote of all Commissioners present.

The Commission adopted the motion by Commissioner Maruca to approve the updated LAFCO Policy Procedures Manual including the updates resolutions. The Motion carried in the affirmative roll call vote of all Commissioners present.
