RESOLUTION OF THE CITY COUNCIL OF THE CITY OF EL CENTRO APPROVING A TAX AND FISCAL IMPACT AGREEMENT WITH IMPERIAL COUNTY FOR THE EXCHANGE OF PROPERTY TAX REVENUES UPON ANNEXATION OF TERRITORY TO THE CITY

WHEREAS, it is necessary for the City Council of the City of El Centro, California ("the City Council") to approve a Tax and Fiscal Impact Agreement ("the Agreement") with the County of Imperial ("the County") for exchange of property tax revenues upon annexation of territory to the City of El Centro ("the City"); and

WHEREAS, the City Council finds that its approval of the Agreement will be in the best interest of the City.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF EL CENTRO, CALIFORNIA, DOES HEREBY RESOLVE AS FOLLOWS:

1. That the foregoing is true, correct and adopted hereby.
2. That the City Council does hereby approve the Agreement between the County and the City for the exchange of property tax revenues and impact fees due to annexations to the City, a copy of which is on file in the Office of the City Clerk.
3. That the Mayor of the City is hereby authorized to sign the Agreement on behalf of the City.
