



A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF  
EL CENTRO APPROVING EL CENTRO ANNEXATION NO.  
EC 1-13 (WILBUR-ELLIS)

WHEREAS, George Arkoosh on behalf of Wilbur-Ellis has petitioned for the annexation of 24.02 acres of land, also known as the Wilbur-Ellis Annexation and as described in Exhibit "A," which is attached hereto and made a part hereof; and

WHEREAS, the Local Agency Formation Commission for the County of Imperial ("LAFCO") has requested that the City of El Centro, California ("the City") conduct its proceedings prior to LAFCO conducting its proceedings regarding said petition and has designated the territory proposed to be annexed as El Centro Annexation EC 1-13; and


WHEREAS, the Planning Commission recommended El Centro Annexation EC 1-13 on April 8, 2013 to the City's City Council via Planning Commission Resolution 14-04.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF EL CENTRO, CALIFORNIA, DOES HEREBY RESOLVE AS FOLLOWS:


1. That the foregoing is true, correct and adopted.
