Report

G.C. § = Government Code Section

1. Purpose of Report

Appoint an alternate public member to the Commission for a four-year term, ending May 7, 2029.

On March 24, 2025, Commissioner Jose Landeros, alternate public member, notified staff that he did not wish to serve a 2nd term. He was appointed to the Commission as the alternate public member on December 21, 2021, for a term of four years. According to Government Code Section 56334, the expiration date of his term of office is Monday, May 5, 2025, and not until the appointment of his successor.

2. State Law

Cortese-Knox-Hertzberg Reorganization Act of 2000:

a. Appointment

G.C. § **56325** (**d**) One representing the general public appointed by the other members of the commission. The other members of the commission may also appoint one alternate member who shall serve pursuant to Section 56331. Appointment of the public member and alternate public member shall be subject to the affirmative vote of at least one of the members appointed by each of the other appointing authorities.

G.C. § 56331 When appointing a public member pursuant to Section 56325, the commission may also appoint one alternate public member who may serve and vote in place of a regular public member who is absent or who disqualifies himself or herself from participating in a meeting of the commission.

b. Notice of Vacancy

- **G.C.** § 56325 (d) Whenever a vacancy occurs in the public member or alternate public member position, the commission shall cause a notice of vacancy to be posted as provided in Section 56158. A copy of this notice shall be sent to the clerk or secretary of the legislative body of each local agency within the county. Final appointment to fill the vacancy may not be made for at least 21 days after the posting of the notice.
- **G.C.** § 56158 Notice required to be posted shall be posted on or near the doors of the meeting room of the legislative body or commission or upon any official bulletin board used for the purpose of posting public notices by, or pertaining to, the legislative body or commission.

c. Qualifications

G.C. § 56331 The public member and the alternate public member shall be residents of the county of the appointing commission. No person appointed as a public member or alternate public member pursuant to this chapter shall be an officer or employee of the county or any city or district with territory in the county.

d. Terms of Commissioners

G.C. § 56334 The term of office of each member shall be four years and until the appointment and qualification of his or her successor. The expiration date of the term of office of each member shall be the first Monday in May in the year in which the term of the member expires.

3. Notice of Upcoming Vacancy

In accordance with Government Code Section 56158, the 1st notice of the upcoming vacancy was posted on the front page of the LAFCo website and bulletin board outside the LAFCo office on March 27, 2025, and the 2nd notice was posted on May 22, 2025.

In accordance with Government Code Section 56325 (d), a copy of the 1st notice was emailed to the county, each city, and each special district on March 27, 2025, and the 2nd notice was emailed on May 22, 2025. For the 1st and 2nd notices, we asked the Agencies to distribute the notice within their Agencies to help spread the notice. For the 2nd notice, we also asked the Agencies to post on the Agencies' social media to help spread the notice.

1st Notice

From March 28 through April 10 of 2025, the notice was posted on the Desert Review's website and printed in their weekly paper on April 2, 2025. On March 29, 2025, the notice was posted on the IV Press's website and printed in their paper. From April 7 through April 10 of 2025, the notice was announced on the KXO Radio Station (AM 1230 and FM 107.5) and posted on their website on April 7, 2025. See the 1st notice of upcoming vacancy (Exhibit B)

2nd Notice

A copy of the notice was emailed to the following Agencies, asking them to post on the Agencies' social media and to distribute within their Agencies to help spread the notice:

- Imperial Valley Regional Chamber of Commerce
- Chamber of Commerce for Brawley, Calexico, and Holtville
- Imperial County Association of Realtors
- Imperial County Farm Bureau

The Imperial County Transportation Commission shared a copy of the notice with its membership. From May 29 through May 30, 2025, and from June 2 through June 9, 2025, the notice was announced on the KXO Radio Station (AM 1230 and FM 107.5). See the 2nd notice of upcoming vacancy (Exhibit A)

4. Application Received

Six applications were received. All candidates are residents of Imperial County and are not officers or employees of the county, a city, or a district. All candidates have indicated that, as a LAFCo member, they have no conflicts of interest regarding decisions. See applications received (Exhibit B)

- **Gilbert Grijalva** is self-employed, a prior LAFCo Commissioner representing the City of Calexico from 1999-2002, and lives in Imperial.
- **Javier Moreno** is retired, a prior LAFCo Commissioner representing the City of Calexico from 2021-2024, and lives in Calexico.
- Blanca Morales is the CEO-Founder of the Calexico Wellness Center Corp, President & CEO of the Southern California Physician Services in Chula Vista, and lives in Calexico.
- Ramiro Urias is the CEO of the Chamber of Commerce for Greater Brawley and lives in El Centro.
- Peter Rodriguez is a retired county employee and lives in El Centro.
- Felipe Irigoyen is the President of Kuhn Hay Inc., CEO of Ametza LLC, and lives in El Centro.

Options

- **Option #1:** Appoint one of the current applicants as the Alternate Public Member to the Commission.
- **Option #2:** Invite the applicants to attend the next scheduled Commission meeting for interviews prior to making an appointment decision.
- **Option # 3:** Direct staff to reopen the recruitment process to solicit additional applicants before proceeding with an appointment.

Recommendation by the Executive Officer

The Executive Officer does not offer a specific recommendation regarding the appointment of the Alternate Public Member at this time. Each of the listed options presents a reasonable path forward, and staff defers to the Commission's discretion on how best to proceed.
