## **ANAYLSIS/REPORT**

#### Background:

New laws and regulations required that we update our website (www.iclafco.com).

During the May 24, 2018 hearing your Commission adopted a final budget for the Fiscal Year 18/19 that included a line item of \$10,000 for a website upgrade.


Staff reached out to the host of our webpage, Conveyor Group and obtained a proposal for a website overhaul. The proposal is attached as **EXHIBIT A.** 

Conveyor Group completed the upgrades and the site went live in October 2019.

#### **Highlighted Updates:**

- 1. Simple navigation and ease of access to information.
- 2. Linking tools that provide easier access to agenda backup materials.
  - Users can access hearing backup by clicking a link on the agenda
- 3. Documentation for converting documents to PDF for ADA compliance.

Final updates will be randomly sampled and tested against three different standard protocols to meet AA level compliance upon completion and relaunch of updated site.
